# Create a legacy by including the library in your will

Here are some considerations.

- Each gift is important no matter the size. Every dollar will be put to very good use.
- It can be hard to decide on an amount. Instead, you can designate a percentage of whatever is left over after the important people in your life have been taken care of. That way, your gift will reflect your changing financial situation during your lifetime.
- You can decide how your money is used. You can direct your gift toward the services, programs and collections at the library that are important to you. But as the library is always evolving, it is good to check with Foundation staff about the best way to word your designation so that it fulfills your wishes years into the future.
- When properly planned, a bequest gift may actually help reduce tax and not significantly affect what your loved ones and heirs would otherwise receive.
- Your intentions and your personal information are always confidential.
